

Subject: Public selection based on qualifications, and supplemented by an interview, for the awarding of 1 Postdoctoral Research fellowship lasting 12 months. The fellowship is renewable for a total of 24 months and is entitled "Science with the SRT - Observational activities in the context of electronic and mechanical interfaces for the integration of new high frequency systems" as part of the project: **"CIR01_00010 - Potenziamento del Sardinia Radio Telescope per lo studio dell'Universo alle alte frequenze radio - rafforzamento del capitale umano". Codice 458573**

Art. 1 - Research project

We announce a public selection based on qualifications and an interview, which can also be carried out by videoconference, for the awarding of 1 postdoctoral research fellowship lasting 12 months and renewable for a total of 24 months. It is entitled "Science with the SRT - Observational activities in the context of electronic and mechanical interfaces for the integration of new high frequency systems" and is aimed at the pursuit of postdoctoral training and research activities as part of the CIR01_00010 project **"Potenziamento del Sardinia Radio Telescope per lo studio dell'Universo alle alte frequenze radio – Rafforzamento del capitale umano"** cited above.

The research fellow will assist in the observing activities in the context of electronic and mechanical interfaces for the integration of new high frequency systems from the Achievement Objective 7 of the CIR01_00010 project. The fellow will invest 50% of the working time in independent astronomical research activities centered on the study of astronomical objects with high-frequency radio observations using single-dish telescopes and radio interferometers. In the remaining 50%, the fellow will carry out Support Scientist activities by assisting the scientific operations of the Sardinia Radio Telescope. The recipient of the contract will work with the Head of Operations of the Sardinia Radio Telescope in the development of a dynamic scheduling system. This system will have to collect information from different subsystem available from the SRT (forecast model of meteo parameters and atmosphere sensors), in order to plan activities in advance of the telescope. The required activity will be the creation of software and a database that allows the implementation of a dynamical scheduling.

This selection procedure is aimed at:

- offering an opportunity for professional growth to young people who hold the title of the PhD, to research fellows or to researchers in fixed-term contracts, who intend to get experience in the national and international research circuits, in a perspective of rotation and mobility, or to recruit specific professionals in the context of projects and/or fixed-term activities;
- covering positions beyond the planning of the need for permanent staff and which, consequently, do not constitute any binding assumption for entering the Institute's permanent positions.

The ownership of the research fellowship referred to in this selection does not foreshadow, on the part of INAF, any responsibility with regard to the future job position of the winner. The ownership of the research fellowship referred to in this selection will not lead to the formation of new forms of precariat at INAF.

The research fellow will need to sign a declaration where they declare:

- to be aware that the grant is co-financed as part of the unitary plan relating to programs owned by the MIUR and, in particular, by the Extract Plan "Research and Innovation 2015-2017";
- to be aware that failure to comply with the requirements of the Notice and this document will result in the revocation of the approved fellowship and the full refund of the amounts received;
- to be aware that the modification of the objectives of the Plan and the attested results (if not previously authorized by MIUR) will result in the revocation of the approved fellowship and the total refund of the amounts already paid.

The training and research activities referred to in this announcement will take place at the INAF - Astronomical Observatory of Cagliari, under the supervision of Dr. Federica Govoni - Scientific Manager of the CIR01_00010 project SRT - **Potenziamento SRT per lo studio dell'Universo alle alte frequenze radio - Rafforzamento del capitale umano** - which will be followed by the appointment of a Scientific Manager for the activities.

Art. 2 - Admission requirements and evaluation criteria for the applications

Participation in this selection is reserved for Italian or foreign citizens who meet the following minimum requirements:

- **PhD in Physics or Astronomy** or equivalent title, issued by a Higher Institute or University, including a foreign one,

or

- An Italian "**Diploma di laurea**" ("vecchio ordinamento") or a **Master's degree in Physics or Astronomy** or equivalent qualification, issued by a Higher Institute or University (including a foreign one); **and subsequent documented experience of at least 3 years in scientific, technological or managerial activities.**

The candidates who will present degrees (Master's degree or PhD) obtained abroad that have not already a statement of comparability ("equipollenza") to the degree obtained in Italy, in accordance with the legislation in force, will be evaluated by the selection committee which will be able to admit them with reserve to the selection, provided they attach to the application of participation the note proving the activation of the request for statement of comparability ("equipollenza") or the request for equivalence ("equivalenza") pursuant to Presidential Decree 189 of 30 July 2009, article 4 with the relative documentation. (Annex c).

The candidates who will have won this selection, and who have obtained their degree in a foreign country, must, for the purpose of completing the work relationship, obtain recognition of the state of comparability of the aforementioned degree, or alternatively produce, within the deadline set by article 9 of this "Selection", the original documents or an authenticated copy of

the original documents according to the provisions of Presidential Decree 189 of 30 July 2009, article 4.

With regard to the "subsequent documented experience of at least 3 years in scientific, technological or managerial activities", it must be presented in accordance with the provisions contained in the Presidential Decree December 28, 2000, number 445 "Consolidated Law on the legislative and regulatory provisions on administrative documentation" and subsequent amendments as well as Law 183/2011, as reported in Article 3 of this announcement.

The following preferential qualifications will be considered:

- scientific experience in radio astronomical research;
- experience in planning and carrying out observations at high radio frequencies with single-dish telescopes;
- knowledge of a programming language such as Python, PHP and MySQL for the development of dynamical websites;
- knowledge of problem solving techniques of optimization (e.g. simulated annealing);
- ability / aptitude for teamwork in complex organizational systems.

Art. 3 - Application for admission and submission procedures

Applications for admission to this procedure, written on plain paper and according to the format set out in "Annex A" and accompanied by the required documentation, must be sent exclusively by certified e-mail ("Posta Elettronica Certificata" or PEC), in non-modifiable "PDF" format, to the following address: inafoacagliari@pcert.postecert.it, with the following subject "***CIR01_00010_458573 Domanda per Assegno Post Dottorato "Scienza con SRT - Attività osservative nell'ambito delle interfacce elettroniche e meccaniche per l'integrazione dei nuovi sistemi ad alta frequenza"***".

Applications must be submitted no later than the peremptory deadline of 05/11/2021 at 23:59 (Italian time), it being understood that the date and time of submission of the application will be certified by the computer system. Late submissions will not be considered.

Please note that the capacity of the certified e-mail inbox is 1 Gbyte, therefore it is advisable to check the receipt of delivery that certifies the correct receipt of the PEC. If not, it is recommended that you submit the documentation in several steps.

The applications sent and the certifications pursuant to Presidential Decree 445/2000 will be considered valid if the author is identified by the computer system through the access credentials relating to the personal users of Certified E-mail (PEC).

The use of certified e-mail (PEC) is mandatory for **Italian citizens, even if they are residing abroad**.

INAF - *Osservatorio Astronomico di Cagliari* assumes no responsibility for the loss of communications due to inaccurate indication of the address by the candidate or failure or late communication of the change of the address indicated in the application, nor for any disservices related to the computer network.

Candidates with disabilities pursuant to law number 104 of 5 February 1992, must make an explicit request, in the application for participation in the selection, in relation to their handicap, regarding the necessary aid, as well as the possible need for additional time for the completion of any interview, pursuant to the aforementioned law.

Aware that false declarations are punishable by law and that the Administration may carry out random checks on the veracity of the statements made, the candidate must clearly and precisely declare in the application, using Annex A and under their own personal responsibility:

- a) last (family) name and first (given) name, place and date of birth,

- g) possession of the requirements indicated in Article 2 of this announcement, date and place of completion and any vote reported;
- h) not to fall under any circumstances of cumulation or incompatibility referred to in Article 4;
- i) not to have been dismissed from another employment at a public administration for persistent, insufficient performance;
- j) not to have been declared forfeited from another employment at a public administration, pursuant to article 127, paragraph 1, letter d), of the Decree of the President of the Republic of January 10, 1957, number 3, for having obtained it through production of false documents or documents vitiated by non-remediable invalidity or by fraudulent means;
- k) not to currently benefit from other scholarships, research fellowships or other types of collaboration awarded for any reason, or to enjoy them and to be willing to renounce them in the event they are the winner;
- l) whether they have previously benefited from other scholarships, research fellowships or other types of collaboration from other public or private institutions and for which duration;
- m) knowledge of the English language;
- n) to specify the postal address where all communications relating to this announcement should be sent;
- o) the certified e-mail address for Italian citizens, or the ordinary e-mail address for foreigners only, to which communications relating to this procedure should be sent, and to promptly notify the administration of any changes;
- p) the declaration of acknowledgment and understanding of the rules contained in this announcement.

Pursuant to the D.P.R. December 28, 2000, number 445 "Consolidated Law on the legislative and regulatory provisions on administrative documentation" and subsequent amendments as well as Law 183/2011, the qualifications that the candidate needs to attach to the application or that the candidate deems useful to produce for the purposes of the evaluation:

if coming from other Italian public administrations, the qualifications must be produced exclusively by means of self-certifications pursuant to art. 46 and 47 of Presidential Decree 445/2000 (Annex B), including a photocopy of a valid identification document: pursuant to art. 15 of Law no. 183/2011, certificates from Italian public administrations or Italian public service operators will therefore not be accepted; self-certifications can also be used by citizens belonging to the European Union;

if coming from private Italian citizens or citizens from the European Union, the qualifications can be produced in photocopy, with a declaration that it conforms to the original, pursuant to Articles 18 and 19 of Presidential Decree 445/2000 or self-certified pursuant to art. 46 and 47 of Presidential Decree 445/2000 (Annex B);

if coming from citizens not belonging to the European Union and not residing in Italy: **in the absence of international conventions between Italy and the candidate's country of origin**, all documents must be produced through original certification issued by the competent authority of the foreign state, accompanied by a declaration of value ("dichiarazione di valore") translated into Italian and authenticated by the Italian consular authority which certifies its conformity with the original, after having warned of the criminal consequences of producing untrue acts or documents (article 3 co. 4 Presidential Decree no. 445 / 2000), indicating the exams taken, the grade and the legal duration of the course of study.

The declaration of value on the spot is issued by the Italian diplomatic-consular representation of the country to which the institution that issued the qualification belongs.

The substitutive declarations, where admitted, must be written in an analytical way, and contain all the elements that make them usable for the purposes of the selection, so that the examining committee can usefully evaluate the qualifications. The self-certifications provided for Italian citizens can also be used by citizens of the European Union (Article 3, paragraph 1 of the Presidential Decree of 28 December 2000, number 445) and by those residing in Italy within the limits set out in Article 3 co. 2 and 3 of the Presidential Decree n. 445/2000. In any case, the Administration reserves the right to verify the veracity of the statements made. Applicants will expressly authorize the processing of their personal data by the Observatory, in compliance with legal obligations.

The list of publications must be presented through a list that contains: Title of publication, Authors, Journal, Year of publication and full address of the site where it can be found.

The application must also contain in attachment:

- 1) curriculum vitae et studiorum, **written in Italian or English, dated and signed in accordance with the methods of articles 46 and 47 of Presidential Decree 445/2000** and subsequent amendments and additions in order to certify the veracity of its content, being aware of the criminal responsibilities in the event of false or untruthful

declarations, pursuant to subsequent articles 75 and 76 of the same decree and the special regulations in force on the matter;

- 2) **Annex B)** certifying the possession of the requirements, referred to in Article 2 of the announcement, and the qualifications for which the evaluation is requested (such as, for example, but not limited to):
 - a. documentation about experience relevant to the subject of this announcement, referred to in the subject matter and in Articles 1 and 2;
 - b. other qualification, job or publication the candidate deems useful to demonstrate their scientific curriculum;
- 3) list of publications;
- 4) list of all documents submitted;
- 5) valid identification document.

For candidates who have earned degrees abroad, one the following must be attached:

- 6) statement of comparability ("equipollenza") if available or receipt of the application for the statement of comparability;
- 7) **Annex C)** with the related documentation if you intend to make use of the provisions of Presidential Decree 189 of 30 July 2009, Article 4 ("equivalenza").

Unsigned applications, or those sent after the deadline and which do not comply with the indications set out in this article will not be taken into consideration.

Candidates are admitted to this selection with reserve and may, at each stage, be notified of their exclusion from the selection for the following reasons:

- the application was submitted after the deadline;
- lack of a copy of a valid identity document;
- lack of the requirements indicated in Article 2.

Candidates excluded from the selection, with motivated provision from the Director of the INAF - Osservatorio Astronomico di Cagliari will be notified by certified mail.

If the reasons for exclusion are ascertained after the conclusion of the selection procedure, the candidate will lose all rights deriving from participation in the selection; similarly we will proceed if the production of false declarations is ascertained.

INAF declines all responsibility for loss of the application or documentation when the applicant has provided incorrect contact details or has failed or delayed to notify any changes.

Art. 4 – Incompatibility

The Research fellowship referred to in this announcement cannot be awarded to INAF employees with a fixed-term or permanent contract.

Furthermore, it cannot be combined with scholarships or research fellowships conferred for any reason, by universities or other research institutions, nor with grants of a similar nature, except those useful in supplementing the activity of the holders of the scholarships/fellowships with stays abroad, granted by national or foreign institutions.

The fellowship winner will have to issue an explicit declaration of non-existence of the aforementioned inadmissible accumulation situations upon acceptance of the fellowship.

The public employee who may be the recipient of the fellowship referred to in this announcement, may be admitted after being placed on leave without pay, according to the current regulatory and / or contractual provisions of the sector, by the Membership Administration. Accumulation with income from work activities carried out continuously, even part-time, is not allowed.

On the other hand, a limited occasional self-employment activity is compatible with the fellowship as long as it does not contrast or delay the activity carried out on behalf of INAF. This activity must be authorized in advance by the Director of INAF - Osservatorio Astronomico di Cagliari.

Art. 5 – Location and duration of the fellowship

The headquarters for the study and research activity will be the INAF-Osservatorio Astronomico di Cagliari.

The research fellowship will have a duration of **twelve months**, and is **renewable up to a total of 24 months** with a provision from the Director of the INAF-Osservatorio Astronomico di Cagliari upon specific request of the Scientific Manager and the Fund Manager, and in the presence of the necessary financial coverage.

Any deferral of the start date of the activity provided for under the fellowship, or any interruptions of the activity itself, will be allowed in accordance with current legislation.

The interruption of the activity that is justified in accordance with the above, involves the suspension of the disbursement of the amount of the fellowship for the period in which the interruption occurs, and in these cases the final deadline of expiry of the fellowship is postponed for a period of time equal to the duration of the interruption.

Art. 6 - Amount of the fellowship and other conditions

The gross annual amount of the research fellowship is **€ 28.000,00** (twenty eight thousand / 00); this amount is to be understood net of social security charges payable by INAF - Osservatorio Astronomico di Cagliari and will be paid in deferred monthly installments.

In fiscal matters, the provisions of article 4 of law number 476/1984 and subsequent amendments and additions are applied; in social security matters, those referred to in article 2, paragraphs 26 and following, of law number 335/1995 and subsequent amendments and additions in addition to the contribution pursuant to article 15 of Legislative Decree no. 22 of March 4, 2015; with regard to the protection of maternity and paternity, the provisions referred to in the Decree of the Minister of Labor and Social Security 4 April 2002 and 12 July 2007, published in the "Official Gazette" number 247 of 23.10.2007 and, in the matter of leave for illness, article 1, paragraph 788 of Law 296 of 27.12.2006 and subsequent amendments. During the period of maternity leave, the allowance will be paid by INPS if in possession of the requirements set out in Article 5 of the aforementioned decree of 12.07.2007 and will be supplemented by INAF up to the amount of the research fellowship. The period of compulsory

maternity leave does not contribute to the duration of the allowance provided for in the contract.

The winner of the fellowship will have to, at their own expense, take out an accident insurance policy that they will have to show at the time of formalization of the work contract, under penalty of forfeiture of the fellowship; the fellow will also have to provide a copy of the registration to the INPS separate management. With regard to the risks of civil liability towards third parties, the research fellow will be covered by an insurance policy stipulated by INAF. The policy does not cover the research fellow's civil liability towards INAF.

Art. 7 - Selection committee

The selection of candidates is carried out by a selection committee appointed by the Director of the INAF - Osservatorio Astronomico di Cagliari.

The examining committee is composed of three members, chosen from among the research staff, including university staff, Italian or foreign, experts in the topics related to the research program described in the announcement. In accordance with current legislation, the composition of the committee must also ensure, where possible, an adequate gender balance. The President of the committee, indicated by the appointment decree, is chosen from among its members. The same decree will indicate the name of the secretary.

Art. 8 - Selection process

The selection is based on qualifications and is supplemented by an in-depth interview. The Committee can assign **100 points**, of which **60 points** is the maximum score for qualifications and **40 points** is the maximum score for the interview; the minimum score for admission to the interview is 42/60 on the qualifications.

The Committee, before proceeding with the evaluation of qualifications, will establish both the maximum score attributable to each of the types of qualifications, and the criteria with which it will assign the score to each qualification that can be assessed taking into account the preferential qualifications indicated in Article 2.

The Committee will evaluate the qualifications according to the criterion of relevance to the topic of the research grant referred to in Article 1.

The assessable qualifications are:

- curriculum vitae et studiorum, written in Italian or English, dated and signed in accordance with and in the manner of articles 46 and 47 of Presidential Decree 445/200 and subsequent amendments and additions;
- publications;
- other scholarship contracts / research fellowships / research contracts;
- other relevant titles.

The Committee, on the basis of the evaluation of the qualifications, draws up the list of candidates who, having achieved a minimum score of 42/60, are considered suitable for the interview. The evaluation of qualifications, after identifying the general criteria, is carried out at the first meeting of the Committee. If the measures relating to the containment and management of the epidemiological emergency from COVID19 persist, all of the meetings of

the examining commission and the evaluation of qualifications can be carried out, for all or some of the members of the commission, electronically.

Those who have submitted the application for participation in the selection within the terms and in the manner referred to in Article 3, and have not received communication of exclusion from the selection and have received the evaluation result of qualifications with at least 42/60 will take the interview **on 23 November 2021 at 11:00 a.m.**

The publication of this announcement is valid as a convocation, it is considered definitive.

In order to comply with the provisions deriving from the epidemiological emergency from COVID19, the Committee reserves the opportunity to carry out the interview at the headquarters of the Astronomical Observatory of Cagliari, via della Scienza number 5, Selargius, or electronically.

Candidates will receive, at least 7 days before the interview, the procedures for carrying out the interview together with the outcome of the evaluation of qualifications.

The interview will focus on topics and subjects relating to the research topic referred to in Article 1 of this announcement. During the interview, the committee will verify the candidate's knowledge of the English language.

To be admitted to the interview, candidates must have an identity document, unless the interview is carried out electronically, in which case the identity of the candidates will be verified by the Committee.

The online interview will take place in the same way as the traditional interview, and is in any case open to the public.

Called candidates who do not show up for the interview on the fixed day will be declared forfeited from the competition.

Candidates who score at least 28/40 will pass the interview.

At the end of the selection procedure, the committee will draw up the merit ranking according to the order of the final score obtained by each candidate based on the sum of the scores obtained in the evaluation of qualifications and the interview.

With equal merit, the younger candidate is preferred.

The ranking will be approved by provision of the Director of the Astronomical Observatory of Cagliari and will be made public on the website www.oa-cagliari.inaf.it and on the website www.inaf.it.

In case the winner withdraws, the research fellowship may be awarded to the next candidate in the ranking according to the decreasing order of merit.

All phases of the activities of the Examining Committee must be carried out in compliance with the protocol of March 14, 2020, stipulated between the Government, trade unions and companies to protect the health and safety of all those involved in this procedure from possible contagion from new coronavirus and guaranteeing the healthiness of the working environment,

throughout the emergency period, as indicated in the Resolution of the Council of Ministers of January 31, 2020.

Art. 9 - Formalization of the work relationship

Within ten days from the date of receipt of the formal communication by certified e-mail, the winner will issue a formal declaration of acceptance of the research fellowship without reservations and under the conditions that will be indicated in the contract that will be stipulated on the date and place established by the Observatory, at the same time certifying that they are not in any of the impediments provided for in Article 4 of this announcement and also declaring their willingness to participate in a post-doctoral training program for their own training needs.

Within the same time limit, the fellowship winner who has submitted the request for equivalence of the qualification (Annex C), must send, if not already done, the relative documents in original or in certified copy of the original to the following address: INAF - Osservatorio Astronomico di Cagliari - Via della Scienza n.5, 09047 Selargius (CA).

Within the same time limit, the fellowship winner who intends to renounce must send a declaration of renouncing the fellowship to the Astronomical Observatory of Cagliari Selargius

The stipulation of the contract does not in any case give rise to a subordinate employment relationship or to rights regarding access to the roles of INAF.

The winner of the fellowship is required to prepare periodic reports on the activity carried out, the frequency of which will be indicated in the contract. These reports must be approved by the Scientific Director of the activities and sent to the Director of the Astronomical Observatory of Cagliari and to Dr. Federica Govoni, as Scientific Director of the CIR01_00010 Project.

Failure to approve, duly motivated by the Scientific Manager, will result in the administration's right to terminate the contract.

In case of withdrawal from the contract, the research fellow is required to give thirty days' notice. The notice period runs from day 1 or day 16 of each month. In case of lack of notice, the Administration has the right to withhold or recover an amount corresponding to the salary for the period of notice not given from the research fellow. The remainder may be assigned to another subsequent candidate in order of ranking, subject to a specific contractual stipulation.

Art. 10 - Effective date and obligations.

The effective date of the fellowship is established by the Director of INAF - Astronomical Observatory of Cagliari, at the time of the convocation for the stipulation of the contract, and can presumably take place by January 10, 2022.

The research fellow has the obligation:

1. to preliminarily sign the contract regulating the collaboration in the planned research activity and anything else contemplated therein;
2. to start on time, unless there is a reasoned temporary impediment to be promptly communicated to the Observatory, on the contractually indicated date, the research activity scheduled at the INAF headquarters - Astronomical Observatory of Cagliari;
3. to continue the research activity regularly and uninterruptedly for the entire period of the fellowship;
4. to observe all the internal rules of the Observatory and the other instructions given by the Director and the Scientific Program Manager;
5. to transmit, to the Director of the Observatory, the periodic reports on the research activity carried out and approved by the Scientific Manager.

The research fellow who, after starting to carry out the planned research activity, does not continue it regularly and uninterruptedly without justified reason, for the entire duration of the fellowship, or who is responsible for serious and repeated failures, or who finally, upon the opinion of the Project Manager, demonstrates evidently insufficient aptitude for the planned research, may incur in the termination of the contract with consequent disqualification from further use of the fellowship with motivated deed from the Director.

The interested party will be notified of the possible start of the internal procedure aimed at a decision to terminate the contract, who will have the right to submit any counter-arguments in this regard with a written memorandum addressed to the Director of the Observatory.

The interested party will also be notified of the conclusion of the same procedure, both in the case of simple filing, without further consequences, and in the event of an effective decision to terminate the contract.

Temporary suspensions in the use of the research fellowship may be justified only in the event that the fellow needs to be absent due to conditions of pregnancy and puerperium, for illness lasting more than one month, or for other serious reasons.

The conditions for suspension of the fellowship will be duly proven and documented, and promptly communicated to the Observatory.

Art. 11 - Procedure manager

Pursuant to Article 8, paragraph 3 of the Regulations for the awarding of INAF research fellowships, the person in charge of the competition procedure of this announcement is Dr. Daniela Stefania Crimi (daniela.crimi@inaf.it).

Art. 12 – Advertising

The full advertising of this announcement is arranged via internet with transmission to the astronomical and astrophysical observatories and to the scientific institutions of the sector in general, publication on the website of INAF (www.inaf.it) and of the Astronomical Observatory of Cagliari (<http://www.oa-cagliari.inaf.it>), as well as on the sites of the Ministry of Education, University and Research and of the European Union according to the procedures indicated by the MIUR.

Art. 13 -Treatment of personal data
