



**Subject: Selection procedure based on qualification and possible interview for the awarding of one research fellowship for 12 months, with possibility of extensions entitled: “Studies of protoplanetary disc evolution within the STRADE project: analysis and interpretation of the data from the PENELOPE-ODYSSEUS and GHOT surveys” Type B “Post-Doc fellowship” CORRECTION OF ANNOUNCEMENT AND REOPENING OF DEADLINES.**

### **THE DIRECTOR**

**IN ACCORDANCE WITH** the own D.D. n. 91/2021(Prot. 1014 del 30.09.2021) to a call for the aforementioned selection procedure, both in Italian and English;

**IN ACCORDANCE WITH** the note transmitted from RUP of the aforementioned selection procedure;

**IN ACCORDANCE** in particular with the art. 3 (application submission) of the aforementioned call, both in Italian and English;

**ASCERTAINED** that in the italian version of the aforementioned art. 3 of the call there is a discrepancy with respect to the english version, the latter foreseeing the application submission through registered mail with acknowledgment of receipt, or express courier, besides the possibility of sending the application via PEC (certified e-mail);

**HAVING DISCUSSED** shortly with the scientific manager of the selection procedure;

**ASCERTAINED** the possibility of amending the aforementioned art. 3 of the call, and for consistency with the English version;

### **DECREES**

**Art. 1** – Notwithstanding the content of the selection procedure, which here must be understood as repeated and transcribed, the art. 3 (application procedure) is amended in the sense of allowing the delivery of the applications for participation in the selection procedure, not only by PEC (certified e-mail), but also using the option of registered mail with acknowledgment of receipt, or express courier, to be addressed to Istituto Nazionale di Astrofisica – Osservatorio Astronomico di Capodimonte, Via Moiariello, 16, 80131 – Napoli;



**Art. 2** – The terms for submitting the application to the selection procedure are reopened with deadline 15 January 2022. The applications sent through PEC (certified e-mail) should be delivered by and no later than 12:00 CET on 15 January 2022.

In the case of applications sent by registered mail with acknowledgment of receipt or express courier, the date of postage stamp in the envelope will prevail.

**Art. 3** – Finally, it is stressed that the applications already delivered using one of the aforementioned media will remain valid, it being understood that those who sent the application, in case of need, are allowed to modify, integrate or replace the application, always in compliance with the rules established in the *“Call for Fellowship”*.
