Selection procedure based on qualifications and possibly an interview for **a postdoctoral research fellowship** (Assegno di Ricerca - Tipologia A), to support work in the framework of the PRIN-INAF SKA-GENESIS

DECREES

Art. 1 - Research project

A selection based on titles and qualifications, possibly integrated by an interview, is open to award one research fellowship, "Assegno di Ricerca – Tipologia A", entitled "Theory and observations of planet forming discs" The activity will be carried out in the context of the PRIN-INAF SKA-GENESIS, with particular reference to the following aspects:

- Observational characterization of planet forming discs, in particular using the ALMA telescope.
- Preparation and submission of dedicated ALMA observational proposals.
- Hydrodynamical modeling of planet forming discs, including both the gas and the dust components.

Art. 2 - Requirements

According to the Italian law for "Assegni di Ricerca" applicants must fulfill all the following requirements in order to participate in the selection:

- Doctorate in Physics, Astronomy or Engineering or equivalent subject, obtained from an Italian or foreign University since no more than 5 years from the deadline of this application,

or

- University Degree in Physics, Astronomy or Engineering or equivalent subject obtained from an Italian or foreign University since no more than 5 years from the deadline of this application and with at least 3 years of experience in research activity after the degree,
- Excellent command of the English language.

Art. 3 - Application procedure

Applications should be sent **in electronic form** (PDF), to the attention of Mr. Luca Ciarfaglia and Prof. Giuseppe Lodato at the addresses: luca.ciarfaglia@brera.inaf.it and giuseppe.lodato@unimi.it Only applications received **by 30/4/2018** will be taken into full consideration. Please quote reference "SKA-GENESIS Fellowship" on all correspondence.

A printed copy of the application, properly signed, shall also be sent by standard mail at the following address: Ufficio Concorsi - Osservatorio Astronomico di Brera, via Brera 28, 20121, Milano, Italy.

A. The applicant should send the following documents:

- (1) Application Form, as available in Annex 1, duly filled in;
- (2) Curriculum Vitae, **duly signed and dated**, detailing in particular the past experiences on the subject of this fellowship;
- (3) Statement of research interests and qualifications;
- (4) List of publications;
- (5) Copy of a valid identity document (ID card or passport);

B. In the Application Form, the applicant must explicitly state, under his/her own responsibility:

- Name(s) and surname, date and place of birth, nationality, place of residence and address for correspondence;
- That he/she satisfies all the requirements described in article 2 of this Call;
- That he/she is aware of and is not ineligible under any of the restrictions described in Article 4 of this Call.

The lack of any of the above mentioned statements would determine the exclusion from the selection procedure for incomplete application.

It is the responsibility of the applicant to provide correct contact details for communication purposes. INAF accepts no responsibility for any miscommunication that may arise due to inaccurate contact details or if such details are out of date. INAF also denies liability for any problem related to the postal delivery service.

Art. 4 - Ineligibility and incompatibility with other funding

The Research fellowship cannot be held either by INAF employees (holding both permanent and non-permanent contracts), nor by regular employees of Institutes listed in article 22, paragraph 1 of Italian Law n. 240/2010. Fellowship holders are not allowed to enroll in a "Laurea Specialistica", or "Laurea Magistrale" (Master Level) degrees, or to enter a PhD program covered by a separate fellowship. For employees of the Italian Public Administration, a compulsory unpaid leave of absence is foreseen. Retired persons are also not eligible for these research fellowships.

The fellowship cannot be held contemporarily with other fellowships of any kind, except those awarded with the aim of integrating the training or research activity of the fellowship holder through a period spent abroad. Aggregation of income from working activities, also part-time, carried out continuously is not accepted. Instead, limited self-employed occasional work is compatible with the fellowship, only if this is not prejudicial to the research activity carried out for INAF. This must be authorized in advance by the Director of INAF-OABrera, where most part of the research activity is carried out.

When formally accepting the fellowship, the successful candidate will declare that he/she is not cumulating fellowships. Also excluded are persons who have been beneficiaries of Research fellowships under article 22 of Italian Law 240/2010 for a total period exceeding six years, including extensions, but excluding the periods in which the fellowship has been held in coincidence with Doctoral studies (up to the maximum legal time limit of the course), as well as periods of maternity leave or sick leave, in accordance with current legislation.

The successful candidate cannot have more than 5 years of research experience after the completion of the PhD (or Laurea Magistrale, in this case she/he needs to have at least 3 years of experience after the degree).

Art. 5 - Duration of the research fellowships

The Research fellowship is awarded for 24 months.

Art. 6 - Host Institution

The successful fellow will carry out his/her research at the Physics Department of the University of Milano, but will be required to spend extended periods of time at the Astrophysical Observatory of Arcetri (Italy) and at the European Southern Observatory in Garching, Germany.

Art. 7 - Salary

The gross yearly salary for this position will be 28.000,00 Euro. This amount is net of burdens to be charged to INAF/OA-Brera and will be paid in deferred monthly installments.

Applicable fiscal rules are the provisions of art. n. 4 of Italian law n. 476/1984 and subsequent modifications and integrations. Applicable social security rules are defined by art. n. 2, paragraph 26 and following paragraphs of the Italian Law n. 335/1995 and subsequent modifications and integrations. Applicable rules for obligatory maternity leave are provided in the Decree of the Italian Ministry of Labour and Social Security dated 12 July 2007, published in the "Gazzetta Ufficiale" n. 247, October 23rd 2007. Applicable rules for sick leave are provided by art. n. 1, paragraph n. 788 of Italian law n. 296, December 27 2006, and subsequent modifications.

During the period of obligatory maternity leave, the allowance paid by INPS (Italian National Institute for Social Security) according to art. n. 5 of the above Decree dated 12 July 2007 is supplemented by INAF up to the total amount of the fellowship. The period of obligatory maternity leave will not contribute to the maximum duration of the fellowship foreseen by the contract.

The winner of the grant will have to take out a working accident insurance to be shown before starting the grant.

Art. 8 - Selection Committee and selection procedure

The selection will be performed by a Selection Committee appointed by the Director of INAF-OABrera and is composed of three members, including the scientist in charge of the project, Prof. Giuseppe Lodato. The selection is based on qualifications, possibly integrated by an interview. The Selection Committee can establish a short list of the eligible applicants to be interviewed, on the basis of titles and qualifications and documented experience in the scientific or technological activities on the specific subject of the research fellowship. If approved by all members of the Committee, the interviews can be performed via videoconference, to ease the procedure for foreign candidates and reduce costs. Applicants selected for the interview will be summoned with 15 days notice.

The total ranking score is 100 points: a maximum of 70 for titles and qualifications, and a maximum of 30 for the interview (which is not mandatory). At the conclusion of the selection procedure the Selection Committee will produce a ranked list.

- 1.up to a maximum of 35 points for the research activity, deducible from the curriculum vitae, carried out at public and / or private institutions, Italian and foreign and private industries and its relevance to the subject of the grant
- 2. up to a maximum of 25 points for refereed publications and international proceedings, taking into account their relevance to the subject of the grant;
- 3. up to a maximum of 10 points for other publications, technical reports and presentations at conferences, taking into account their relevance to the subject of the announcement.

Art. 9 - Awarding of the fellowship

The highest-ranked candidate will receive a written notification with an offer of the research fellowship, which will be anticipated by e-mail to assure a speedy process. Within 7 days from receipt of the formal notification of the award, he/she must provide a formal declaration of acceptance of the fellowship, or of withdrawal. The declaration can also be anticipated by electronic mail. In case no declaration is received, the candidate is considered as withdrawn and thus excluded. The committee can then move down the ranking and repeat the procedure with the third-ranked candidate, and so on, until the fellowships are accepted.

Under no circumstances the signing of the contract will start a subordinate employment relationship or ensures any rights to access to permanent INAF staff positions.

Art. 10 - Starting date and fellowship obligations

Expected starting date of the research fellowship is 1st July 2018. The holder of the fellowship:

will start the research activity on due date, as for the contract with INAF OA Brera, unless
prevented by force majeure or exceptional circumstances, of which the Director of INAF-OA
Brera must be timely informed;
□will carry out her/his research activities under the supervision of the Principal Investigator of
the project, Prof. Giuseppe Lodato, who will also monitor the fellow's progress;
\Box is required to issue periodical activity reports as established in the contract. The activity
reports will be subject to approval by the project supervisor. Approval failing, duly justified by
the supervisor, will give INAF - OA Brera the right to terminate the contract;
\square In case of resignations, is required to notify in written form OA-Brera Director at least 30 days
in advance of the expected date of terminating the appointment. If failing in this obligation,
INAF OA Brera will be entitled to retain (or request the reimbursement of) the amount of
salary corresponding to the fraction of the 30-day advance-notice period not fulfilled.

The holder of the fellowship who fails in carrying out his/her regular research activity, without producing justified reasons or lacks repeatedly to fulfil requirements or, according to the evaluation of the scientist in charge, eventually shows evident lack of skills at the planned research activities, will incur in the termination of the contract.

Temporary suspensions of the research fellowship are due in case of obligatory maternity leave or in case of illness lasting longer than one month or to any other serious reason. The reasons for suspending the research fellowship must be proved and certified, and promptly sent to the Director of INAF-OABrera.

Art. 11 - Personal Data

In accordance with art. 13, paragraph 1 of the Italian Legislative Decree n. 196/2003 and subsequent modifications, personal data provided by the candidates will be used exclusively for the purposes of this selection. Candidates who wish to obtain further information, or to exercise their rights under art. 7 of the above mentioned Legislative Decree, may contact the responsible administration employee for this call.

Art. 12 - Responsible Employee

The responsible administration employee for this job announcement processing is Mr. Luca Ciarfaglia.

Art. 13 - Applicable regulation

INAF-OA Brera shall abide by provisions in force promoting equal opportunities for women and men, non-discrimination and respect of privacy in processing personal data. For what not explicitly mentioned in this announcement, INAF-OABrera shall act in compliance with the regulations in force concerning Italian public selection procedures, when applicable by analogy.
